Release, Waiver of Liability and Assumption of Risk

1. ACKNOWLEDGES, AGREES AND REPRESENTS that the Activity in which participant is to voluntarily engage may involve the risk of bodily injury or property damage;
 2. RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE THE NATIONAL CHERRY FESTIVAL, INC., and all affiliated entities, promoters, participants, sponsors, advertisers, rescue personnel, owners and lessees of the premises and equipment, their directors, officers, agents and employees (collectively, the "Releasees") FROM ALL LIABILITY TO PARTICIPANT AND PARTICIPANTS PERSONAL REPRESENTATIVES, ASSIGNS, HEIRS AND NEXT OF KIN FOR ANY AN ALL LOSS OR DAMAGE AND ANY CLAIM OR DEMAND THEREFORE ON ACCOUNT OF INJURY TO PERSON OR PROPERTY ARISING OUT OF THE ACTIVITY, WHETHER CAUSED BY THE NEGLIGENCE OF THE Releasees or otherwise;

AGREES THAT THIS Agreement extends to all acts of negligence by the Releasees and is intended to be as broad and inclusive as is permitted by the laws of the State of Michigan and that if any provision(s) of this Agreement is held invalid, it is agreed that the balance of the Agreement shall continue in full force and effect;
 6. CERTIFIES THAT PARTICIPANT HAS HEALTH, ACCIDENT AND LIABILITY INSURANCE to cover bodily injury or property damage that Participant may cause or suffer while engaging in the Activity at the National Cherry Festival;
 7. REPRESENTS that, if the Participant is under 18 years of age, the undersigned is the parent or legal guardian of Participant and has the legal capacity and authority to enter into this Agreement on behalf of Participant, or that, if Participant signs on his/her own behalf, Participant is at least 18 years of age.
